



2019 VENDOR APPLICATION

The Goodlettsville Farmer's Market will be held on **Thursdays 3:00-7:00 pm, May 2 - October 10 (No Market on July 4th)** and will be held on the lawn at the Goodlettsville Visitor's Center at Historic Mansker's Station, 705 Caldwell Drive.

Farmers will receive first priority for booth spaces and all other vendors will be considered on a case by case basis based on demand, originality, and quality of product.

Vendors intending to sell products that are regulated by local, state and/or federal agencies **MUST** include copies of ALL appropriate documentation from those agencies ensuring compliance prior to final acceptance. Applications without all documentation will not be considered. This application does not guarantee you a booth at the Goodlettsville Farmer's Market.

APPLICATION CATEGORIES

Farmer – a vendor that grows and sells the following: produce, dairy, meat/poultry, cut flowers, vegetable transplants and nursery stock.

Non-farmer – a vendor selling the following: baked goods, crafts, soaps, jewelry, art, food or beverages

Food truck – a vendor selling any food or drinks being served for immediate consumption.

Entertainer – a performer such as a singer, musician, dancer, or comedian, whose job is to entertain at the farmer's market

VENDOR FEES

Vendor fees include one (1) 10 x 10 space.

Full Time Vendor - \$180 (all 23 dates)

Part Time Vendor - \$100 (12 dates – every other Thursday plus the final date)

Fill in Vendor - \$20 per day

Full Time Food Truck - \$200 (all 23 dates)

Part Time Food Truck - \$35 per day

SECTION A: FARMERS

A Farmer is a vendor selling the following: Produce, Dairy, Meat and/or Poultry, Cut Flowers, Vegetable Transplants and Nursery Stock.

All Farmers are required to label their products with approved labeling: Price, City or County and State in which it was grown, method used for growing (i.e. Conventional, Chemical Free, Organic, etc). All information should be clearly marked on all items.

To participate, all vendors must be "Local". Local is defined as living and producing at least 75% of their own products within 100 miles of Goodlettsville, TN. The 25% of products that are not produced by the vendor must be approved by the Market Manager before they will be allowed to sell at the Market.

Dishonesty and/or failure to follow these labeling regulations will result in a verbal warning for a first offense, a two week suspension from the Goodlettsville Farmer's Market for a second offense, and expulsion from the market without any refund of prepaid fees for a third offense. This will be strictly enforced.

All Farm Vendors are subject to a farm inspection conducted by the Goodlettsville Farmer's Market Market Manager.

Please be aware, food vendors must meet all required health and fire safety standards and are solely responsible for passing all inspections.

The vendor fee for food trucks is \$200 for all 23 dates. If you plan on working select dates, the fee is \$35 per Farmer's Market day and will need to be paid on Monday before the Thursday market or you will not be able to work the market.

In addition to the vendor fee for the Farmer's Market, the City of Goodlettsville requires a mobile food vendor permit which is valid for one calendar year. The application and permit may be obtained thru the City Clerk's office at 615-851-2209 or ESimpson@Goodlettsville.gov. Upon receipt of a copy of this permit to the Market Manager, the application and permit fee will be deducted from the \$200 vendor fee, and you will simply owe the balance.

Fill-in vendors are responsible for paying on the Monday prior to the Thursday market date. The selection process is based upon the needs of the Goodlettsville Farmer's Market, and placement is at the Market Manager's discretion.

Should you be required to take an extended leave of two or more consecutive market days from the Goodlettsville Farmer's Market for any reason, your space may be filled from a waiting list. You will be able to return if space becomes available. Dates may be added or removed at Market Manager's discretion. If a vendor cannot attend their scheduled date, they must contact the Market Manager at least 24 hours before the market opens. If the vendor does not notify the Market Manager and does not show up, they will be moved to a waiting list and there will be no refund.

PHOTOS

All applicants must submit photos with your application for it to be considered. Farmers should include at least one photo of your farm or farming operations. Non-farmers should include at least one work-in-progress photo of your merchandise.

ALLOWABLE MERCHANDISE

All items sold by Vendors at the Goodlettsville Farmer's Market must comply with this list.

- Produce defined as fruits, vegetables, herbs, honey and mushrooms. All produce needs to be labeled using approved labeling methods.
- Dairy defined as locally produced eggs, pasteurized milk and cheeses. Producer must furnish adequate labeling and refrigeration and must meet state and local health regulations. Vendors must have USDA inspection certificate if they are processing or preparing their own goods.
- Meat and poultry defined as locally produced, processed and packaged meat and poultry products. Producer must furnish adequate refrigeration and meet state and local health regulations. Products must be packaged by a certified USDA inspected facility. All certifications will need to be given to the market manager two weeks prior to opening day.
- Cut flowers and vegetable transplants include cut flowers loose or bundled and vegetable transplants and seller must meet state and local certified regulations.

- Nursery Stock includes potted perennials plants, bare root perennials, tree stock and shrubbery. Nursery growers must be certified according to state and local certified regulations.
- Canned defined as highly acidified canned goods, as well as jams and jellies. All items must meet state and local health regulations including the inspection of the vendor's kitchen by health inspectors and labeling in compliance with the regulations if certified. Vendors must have a copy of their Kitchen Certification form on file with the Market Manager, as well as with them when selling at the market. If you are NOT certified, then you must provide proper signage at your booth stating that your product was created in a Non-certified kitchen. The product must still be packaged and labeled properly.
- Baked Goods defined as baked items from a certified kitchen. This includes, but is not limited to breads, cakes, brownies, cookies, and fruit pies. All items must meet state and local health regulations including the inspection of the vendor's kitchen by health inspectors and labeling in compliance with the regulations if certified. Vendors must have a copy of their Kitchen Certification form on file with the Market Manager, as well as with them when selling at the market. If you are NOT certified, then you must provide proper signage at your booth stating that your product was created in a Non-certified kitchen. The product must still be packaged and labeled properly.
- Crafts defined as locally produced soaps, crafts, and fine art products. All items must be hand crafted by the vendor and not a resale item.
- Food and Beverage defined as any food or drinks being served for immediate consumption.
